

## **Liability Release, Waiver, Discharge and Covenant Not to Sue**

*This is a legally-binding Liability Release, Waiver, Discharge and Covenant Not to Sue made by me, \_\_\_\_\_, (hereinafter referred to as “Releasor”), to the International Society of Krishna Consciousness of Mississippi, Inc. and Iskcon of Gulf Coast, Inc. (hereinafter referred to as the “Organization”).*

*I fully recognize that there are dangers and risks to which I may be exposed by participating in gardening, kitchen work, working in the fields, being around equipment and farm animals and etc. During/on the time I am at the New Talavana temple / farm complex. The following is a description and / or examples of significant dangers and risks associated with activities at New Talavana. It is not possible to list all possibilities a person may confront but this is just a general run down of common possibilities.*

- *Bending over and working on hands and knees exposed to the elements and weather.*
- *Working in areas where insects, reptiles, dogs, and other creatures may be.*
- *Swimming ponds or conservation ponds in the immediate area.*
- *Using sharp equipment such as knives, sickles, hoes, racks, and various other farming or kitchen equipment.*
- *Being around farm and kitchen equipment.*
- *Being around electricity, gas and wood fires; and living in old rustic facilities.*
- *Climbing up and down stairs.*
- *Driving in vehicles.*
- *One hundred one other things and possibilities of injury or even death by unforeseen circumstances and events.*

*I understand that the Organization does not require me to participate in any activity, but I want to do so, despite the possible dangers and risks and despite this Release. I, therefore, agree to assume and take on myself*

*all of the risks and responsibilities in any way associated with service or living at New Talavana. In consideration of and return for the services, facilities, and other assistance provided to me by the Organization (and its governing board, employees, and agents )I exempt them all from any and all liability, claims and actions that may arise from injury or harm to me, including death, or from damage to my property in connection with living at New Talavana. I understand that this Release covers liability, claims, and actions caused entirely or in part by any acts or failures to act on my part, including but not limited to negligence, mistake, or failure to supervise.*

*I assure the Organization that there are no health-related reasons or problems which preclude or restrict my participation in activities at New Talavana. I further assure the Organization that I have adequate health insurance necessary to provide for and pay any medical costs that may directly or indirectly result from my participation in this activity, and I will indemnify and hold the Organization harmless for any such medical costs. I understand that this Release means I am giving up, among other things, rights to sue the Organization, its governing board, employees, and / or agents for injuries (including death), damages, or losses I may incur. I also understand that this Release binds my heirs, executors, administrators, and assigns, as well as myself.*
